INSTRUCTIONS FOR USE

One dose = 20ml.

Dilute SANICID® 5 PARFUME from 0,25% to 2%.

Use in wet wiping or to wash floors, surfaces, furniture and sanitary.

Do not rinse (unless in contact with foodstuffs).

The diluted product can be stored for up to 7 days in a closed bottle and stored according to the recommendations of the MSDS, otherwise 24 hours maximum.
